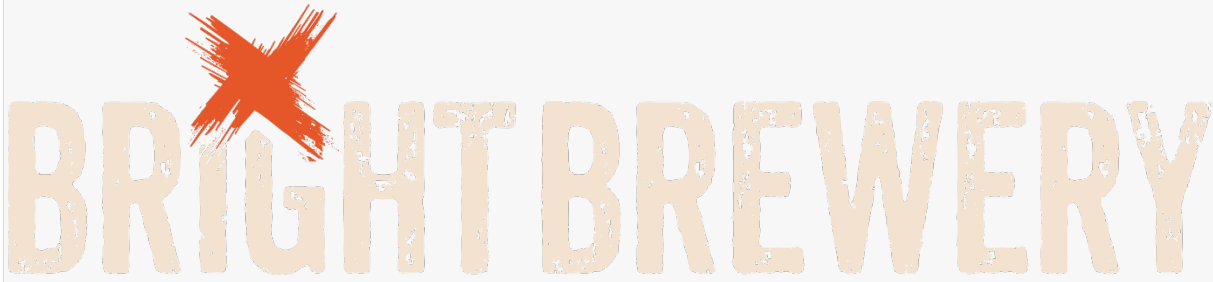


Liability Waiver for Darker Days Hot Dog Hotdog Eating Competition
